## CORRECTION TO 2013 CONSOLIDATED ELECTION CALENDAR - DEADLINE FOR CERTIFYING PUBLIC QUESTIONS TO THE ELECTION AUTHORITY IS JANUARY 31, 2013

### December 14, 2012

The 2013 Consolidated Election Calendar incorrectly identified Thursday, February 7, 2013 as the last day for local election officials to certify to the election authority all public questions to be placed on the ballot for the April 9, 2013 Consolidated Election. The correct date for certification of public questions is Thursday, January 31, 2013. Accordingly, the February 7, 2013 item in the Calendar should be deleted and the January 31, 2013 deadline for certification should be inserted as follows:

DATE	DAYS BEFORE ELECTION	PERSON RESPONSIBLE	EVENT
Thursday, 1/31/13	68	Secretary of Board or Municipal Clerk	Last for local election official to certify all <b>public questions</b> to the election authority. (10 ILCS 5/28-5)
Thursday, 2/7/13	61	Secretary of Board or Municipal Clerk	<del>Last day for local election official to certify all <b>public questions</b> to each election authority. (10 ILCS 5/28-5)</del>
